Message from the President:

On Monday May 13th, a homeowner stated that the association lock on the gate at the north end of FP Dr had been pilfered. A bolt cutter had been used to cut the lock off. Photos were sent to directors. A new lock was installed that day.

The No bicycles sign on the walking path is being ignored, so a notice needs to be posted in the Splash and the Community E-mail to remind members. Strollers are permitted. The path was refurbished in 2014 at a cost of \$30,400. The projected refurbishment is in 2029 for a cost of \$46,365. So, doing all that we can do to extend the life of the path is necessary. Garbage trucks have continued to turn around in the parking lot after several calls to the city to stop them.

The driver stated that they go into the parking lot to check for cans, even though the cans were removed last August. He will contact Mapping and have the area deleted from the driver's pick up list.

[Editor's note: The parking lot is Fountain Park private property and does not belong to the City of Tucson like the streets do.]

Treasurer's Report

Greetings and welcome to the summer scorch, ready or not!! No surprises there!

No surprises in the May financial report either, other than happily for the second straight month, the delinquent account balance is under \$700, and that is good for all. Income in May was \$13,324; expenses stayed at under \$6000 (\$5043), resulting in a net income of \$8281. Our operating account shows \$41,737, up from previous months this year. Our Reserve account balance, \$43,613 was up slightly from April, although only momentarily as the next installment of the pool contract (\$12,813) was debited, bringing the current balance to \$30,799. However we do continue to steadily, if slowly restore the Reserve funds by transferring \$3400 each month from our

Operating account. Once the pool contractor works out the issue with the Pebble Tec interior surface, there will be only one remaining payment of \$4000 to them. A French drain and a new ramada floor (to be completed in late Fall), totalling under \$10,000 for both, are also planned. Over \$174,000 has been spent on the pool renovation.

Administrative, maintenance and utilities costs continued to be underbudget in May, as they have been since the beginning of 2019; positive news as we move forward into the second half of the year.

The topic of raising the annual assessment (dues) was discussed at the June Board meeting and it was determined that at this time, there is no justification for an increase, according to the requirements set by the HOA's CC&R's. We have met and continue to meet our financial obligations. It was decided

to review the annual assessment for next year during the 2020 budget preparation, which will take place in October or November of this year.

Landscape:

It is natural for our lawn to look brown at this time of year. The winter rye grass is dying back and the bermuda has not yet taken hold. The Landtamers crew is relocating some of the sprinklers to provide more complete coverage.

Gophers are active in the lawn area. Horn Pest Management will deal with them June 13th.

Lantanas have been planted on the 2nd median and along the north path entrance. Estimated cost is \$120 for 14 plants. Our maintenance crew did the planting at no additional cost. Irrigation lines were run to all plants. We donated a roll of spaghetti tubing to help with the cost.

"The deck was textured and received the 1st of 2 coats of paint (tea and cream beige); a seal coat will be applied after the pool is filled. The interior deck edge pavers are also a beige tone with small white shell inclusions.

Splash

Per code, each entry step has a row of cobalt blue tiles, and non-skid depth & "No Diving" tiles are in place. Deck drains for water run-off and the pump room equipment are all being installed. A recent community email advised of delay in the pool interior finish due to loss of a subcontractor's truck as well as Arizona's pool building boom. Trucks can be as large as fire engines, and our pool requires 2 simultaneously for the project. Imperial Pools is working hard on finding a solution."

The only approved exterior paint colors for Fountain Park are Dunn-Edwards Weathered Coral, Cienega Brown & Fountain Park Beige. They are available at Dunn-Edwards at Speedway & Columbus (327-6011) and at Broadway & Prudence (296-3875). To get the Fountain Park discount use account number 6085276! Our account representative is Isaac Jacques, 909-0425. All exterior surfaces including front doors must be painted in the approved colors. All wrought iron shall be painted black or one of the approved colors. All slump block walls visible from the street shall be Cienega Brown with a trim color for the cap. Reference FPHOA Rules and Regulations. Changes to the color patterns on your home must be approved by the board. Gravel We can purchase gravel at a discount from D & D Materials LLC, Landscape Rock, at 7777 E .22nd St. Ask for Dustin and show a copy of Fountain Park Splash to get \$4.00 off each ton of rock. We can also purchase 5 gallon buckets of any kind of decorative rock for \$2.00. You bring your own bucket and shovel.

Lights

Keep your garage light fixtures in good working order and lit at night. This is a FPHOA requirement. Please check periodically to see if your outside garage light is working. Our garage lights are the only lighting we have to help keep our community safe and give light to our house numbers. This can be lifesaving in case of emergencies. Reference CC&R Art VI Sec. 6.2.

Construction and Finish Garage and front porch lights must be made of glass and bronze or antique brass. See R&R pg2, item 5. Wrought iron or other metal and ceramic fixtures are not acceptable.

Size: Should not exceed 24 inches in height and 7 inches in width, including ornamentation.

Light Bulbs: Should cast light in a 180 degree arc with minimal light exiting through the top of the fixture. Bulbs should not exceed 80 watts total for the fixture.

Placement: To fully illuminate the house numbers, fixtures may be moved up to a maximum of 24 inches from the original position...City Ord Ch. 4 Sec 401 states that light sources must be shielded and directed in a limited radius. Remember this when adding any other outside lighting such as security spotlights.
