1. **Call to Order**. A quorum was present and the meeting was called to order at 10:01a.m. Alicia Navia welcomed everyone for participating in the first Annual Zoom meeting. This is a recommended abbreviated agenda; our purpose is to vote on a new Board.

- 2. **Roll Call**. All Directors confirmed their attendance by voice. Alicia noted that Donna Wood, Property Manager, and Joan Groom, Meeting Minutes, were also in attendance.
- 3. **Proof of Notice.** Pinehurst Properties mailed notices of Nominations on December 4, Electronic Ballots went out on December 23, a note to please vote was sent on December 30, a reminder was sent to those who had not yet voted on January 4<sup>th</sup> and a final meeting notice was sent on January 14.
- 4. Election of Directors & Approval of 2020 Annual Meeting Minutes

Nominating Committee Chair Claire Callahan reported that if not for COVID-19, the Nominating Committee would not have selected Election Buddy. She thanked Dario Navia for mastering the intricacies of Election Buddy (with minimum help from Election Buddy) and keeping the costs down. Election Buddy cost is \$89 to electronically send ballots to 168 of 180 homes. Twelve homes without access email were mailed ballots for a cost to the HOA of \$35.40. Total expense for the election this year was \$124.40. The cost for last year's annual meeting was \$553.33. So we saved \$428.92 this year.

While waiting for voting results, Melissa Lovelady announced the Survey for the common area in the park will go out soon. Please look for an email from Survey Monkey in your inbox by mid-February.

Alicia announced it was 10:15 a.m. and voting was officially closed. Claire received one mail-in ballot.

The January 18, 2020 Annual Meeting Minutes were unanimously approved by homeowners in attendance.
